# USING AA'S LITERATURE IN CARRYING THE MESSAGE

## Should I Go to AA?

When I started to see a problem with my drinking, one of my favorite things to google was "Should you go to AA?" In all of my searches, I found conflicting information because I didn't know what exactly what I was looking for.

Truthfully, at that point, I was looking for something to tell me that I wasn't an alcoholic, so those were the websites I visited and I looked for how I didn't belong.

Until one day, I walked into my first meeting. I was told there was free literature on the back table and if I was a newcomer, I shouldn't leave the meeting without a Big Book. I started to look at all the pamphlets. There were so many that I related to: "Do You Think You're Different?" "Is A.A. For Me?" "Young People and A.A." — The pamphlets were so easy to read and helped me to not feel so alone. As I started working with my sponsor, I bought the 12&12 to help deepen my understanding of step work. I later found Daily Reflections, which helped me jump start my day with recovery.

When I was two years sober, I was struggling badly with my mental health. I went into my first appointment with a psychiatrist and was completely honest about everything going on in my head and how important my sobriety was to me. Shortly after my mental health diagnosis, I found a new pamphlet "A.A. for Alcoholics with Mental Health Issues — and their Sponsors". It was so important to have AA-approved literature in my hands (and the hands of many others) to further spread the correct message. Had I only relied on my earlier google searches, I would still be out there praying for the life I have today.

## Is it OK to use non-conference approved literature in meetings?

In 1978 the AA General Service Office described what "Conference Approved" means in their Box 4 -5-9 newsletter (Volume 23, No 4). Here the General Service Office said:

"It (Conference Approved) does not mean the Conference disapproves of any other publications. Many local A.A. central offices publish their own meeting lists. A.A. as a whole does not oppose these, any more than A.A. disapproves of the Bible or any other publications from any source that A.A.'s find useful.

What this means to me is that each group is autonomous to use whatever literature they feel most useful to their group. In AA, each group is the highest authority in AA!

Conference approved literature is what represents the *common message* of our program of recovery. I am so grateful that most of the meetings I've attended shared the same message, used the same language, and through repetition of the steps and traditions, paved a way out of darkness into the light for so many of us to be happy, joyous and free!

Why conform to the masses by embracing popular religious or recovery literature? Be unique and break away from the norm by choosing a different path.

### Declare your autonomy and explore AA's Conference literature instead!

Embrace our freedom to explore any literature – external works, personal accounts, or conference-approved materials. AA has no opinion and never has expressed public disapproval. Before the Big Book and Grapevine, there were no AA written works. Everything lacked Conference approval due to the absence of a conference.

But our Conference-approved works are like buried treasures. They are the collective toil of years and the best efforts of thousands. Few attempts to dominate another life or restrict spiritual growth get by our substantial unanimity or rights of appeal. Imperfections and attempts to dominate our lives are minimal.

## These unique attributes grant us more freedom to become what or whomever we are meant to become.

Like the swinging orbs of Newton's Cradle, the collective energy of AA thrives when aligned and guided by carefully refined publications. Our pamphlets are even more current and alive with potential energy; they are the best example of decades of refinement, but, they must be set in motion. Subtle choices in wording protect our possibilities and spiritual liberties. Straying too far from this sort of guidance with newcomers risks diminishing the transformative power or even pushing people away from the AA message. When meeting new people, who often aren't seen again, a pamphlet might be their first and last chance to learn accurately about AA. So, it's important for sharing precisely what AA is about. We can avoid reinventing the wheel each time, erase misconceptions and unload some of the burdens of their successes or failures off of our shoulders and onto the fellowships. Embracing this shared approach is indeed an easier, softer way.

In conclusion, embracing the importance of AA literature and unity empowers individuals to create meaningful lives in sobriety while maintaining their independent spirits. The collective wisdom of the AA community is an invaluable resource that can guide us on our journey to recovery.

So, fellow mavericks, sons and daughters of rebellion, and outlaw safe crackers, saddle up and mask up; we've got nuggets of newfound freedom and happiness to uncover and revisions to plunder!

## Cooperation with the Professional Community (CPC)

It was recommended that:

The pamphlet "A.A. in Your Community" be approved with minor editorial changes

#### **Corrections Committee**

The committee recommended that item #5 in the Procedures of the Conference Committee on Corrections be revised to read: "To maintain communication with committee secretary and other committee members during the year."

The following section be added to the pamphlet "A.A. in Correctional Facilities" on page 12:

**Sponsorship** "Like all A.A. members, persons in custody can benefit from sponsorship. For more information, please refer to the Corrections Kit and Workbook or contact your local Corrections committee.

#### Literature Committee

It was recommended that: The revised draft of the existing version of the pamphlet "The Twelve Traditions Illustrated" be approved.

The print version of the pamphlet "Too Young" be retired and the content be repurposed as an animation video at an estimated cost no higher than \$70,000. The committee requested that a progress report or a rough cut of the video be brought back to the 2024 Conference Committee on Literature

## Literature Committee (Contd.)

The work on the draft pamphlet based on A.A.'s Three Legacies be ceased. The committee notes that the material gathered would be most useful as service material.

#### Finance Committee

It was recommended that:

The materials produced and maintained by A.A. World Services, AA Grapevine, La Viña, and the General Service Office (GSO), clarify that the General Service Board is the entity which receives all voluntary A.A. contributions and that GSO performs contribution processing. Any text changes should be implemented when each item comes up for reprint or revision.

The suggested area contribution for delegate expense for the Conference be increased from \$1,800 to \$2,200.

The Trustees Finance and Budgetary Committee develop additional ways to report quarterly the fiscal performance of the AAWS, GSB and GV Boards throughout the year to the members of the General Service Conference for the purposes of transparency and assisting in the reporting to the A.A. Fellowship.

## **Grapevine Committee**

No recommendations.

## International Conventions/Regional Forums Committee

It was recommended that:

The following three cities be considered as possible sites for the International Convention in 2035:

\*Phoenix, Arizona \*Indianapolis, Indiana \*New Orleans, Louisiana

The committee recommended that up to 21 non-A.A. speakers be invited to attend the 2025 International Convention at A.A.'s expense.

## **Public Information (PI) Committee**

It was recommended that:

The Membership Survey pamphlet be updated to reflect the findings from the 2022 Alcoholics Anonymous Membership Survey, with minor editorial changes.

The AAWS Board prepare sufficient periodic analytics reporting on our current and the Conference Committee on Public Information.

## Report & Charter Committee

It was recommended that:

The A.A. Service Manual not be printed in 2023 and that a new edition be published biennially (i.e., every two years), beginning in 2024.

A full rewrite be conducted of chapters 8, 9, 10, 11 and 12 to correct inaccuracies and to better clarify the

World Services, Inc. in The A.A. Service Manual and to the 2024 Conference Committee on Report and Charter.

Anonymity-protected Conference Final Reports be posted annually on aa.org beginning with the 2023 General Service Conference.

#### **Treatment & Accessibilities**

It was recommended that:

The revised pamphlet "A.A. for the Older Alcoholic— Never Too Late" be approved with minor edits in a format that does not require folding.

The 22 interviews recorded to date as part of the Military Audio project be approved, giving the General Service Office (GSO) the latitude to distribute the audio interviews in various formats and on various platforms, and that an update report be provided to the 2024 Conference Committee on Treatment and Accessibilities.

#### **Trustees**

It was recommended that:

The new slate of trustees of the General Service Board be elected at the annual meeting of the members of the General Service Board on April 29, 2023, following presentation at the 2023 General Service Conference for disapproval if any.

What he did need, when we first met, was the deflation at depth and the understanding that only one drunk can give to another. ## **Two Types of Area Meetings**

- Quarterly Meeting: Decides area business. DCMs, Area Officers and Coordinators, past Delegates vote.
- Area Assembly: Elects officers, provides pre-Conference group conscience, hears the Delegate's post-Conference report. GSRs, DCMs, Area Officers and Coordinators, past Delegates vote.

**ALL** members of the Fellowship are welcome at meetings and assemblies. GSRs are especially encouraged to attend even when they do not have a vote.

Every GSR is potentially a future DCM.

## Rules of Order at Area 60 Meetings

- Items for consideration are put on the agenda.
- Items are posed to the meeting in the form of a **motion**.
- All motions require a second.
- Motions can be amended, tabled, or moved to a vote.
- A vote is taken and the results are announced. The minority vote is allowed to voice its opinion.
- If a member of the majority (those who "won") wishes to change their vote, a second vote is held on the motion.
- The result of the second vote stands and the meeting moves to the next item for consideration.

#### What's the "Point "of Order?


- To ensure that all voices that wish to be heard are heard.
- ♦ To ensure that no one voice dominates all others.
- To ensure that everyone gets to speak once before another speaks twice.
- ♦ To ensure that everyone understands the content of the vote.
- ♦ To ensure that it is clear what actions were taken.
- ♦ To ensure a thorough record of the actions taken.

Motions requiring substantial unanimity of the meeting require a twothirds majority for approval. In some cases, the minority opinion (the people who "lost" the vote) may be larger than 50% of the vote.

## Area 60 Web Calendar


