## FELLOWSHIP VS. MEMBERSHIP

**Tradition 3: The only requirement for AA membership is a desire to stop drinking.**

That being said, I was a member the first day I walked into Butler Memorial Hospital detox. I had the desire to stop drinking. But it took me a long while to find out what the Fellowship of AA really was.

After getting out of rehab, God removed the desire to drink. I started to attend AA meetings, got a Home Group and a sponsor, but I was just *there*, not really participating. I was sick, still dying from cirrhosis, my head in a fog bank. No wonderful pink cloud for this alcoholic.

I was attending the Crafton Group, the 12th oldest group in Pittsburgh (I learned this from reading *Seeds of Service*, Summer 2013). There, I found a group of people I started to connect with. They all treated me with love and respect and I kept coming back. At one point, they thought I was a Home Group member; a couple of years later, when I felt like I was stagnant in my own sobriety and needed to grow, I made Crafton my Home Group.

I got involved with a group of guys meeting every Friday night at the home of one of the fellows to read the Big Book. When one of us does our lead at a speaker meeting, we road-trip to support him. We go to Cook Forest, recovery comedy shows, and much more. I found a new sponsor in this group, who God has graced with the comprehension of the word serenity and has come to know peace. I know if I practice these principles in all of my affairs the way he does, I will get what he has.

I felt alone most of my life, and only dreamed of having a fellowship of friends grow up around me.

***This fellowship is far greater than what I ever believed I would get when I became a member of Alcoholics Anonymous.***

In regards to AA, **fellowship** means two things to me: an *experience* and an *organization*. The two paragraphs quoted from the Big Book below seem to really hit the mark to distinguish them:

*To watch people recover, to see them help others, to watch loneliness vanish, to see a fellowship grow up about you, to have a host of friends – this is an experience you must not miss.* (“Working with Others,” p.89)

...and...

*You should be described to him as one of a fellowship who, as part of their own recovery, try to help others and who will be glad to talk to him if he cares to see you.* (“Working with Others,” p.90)

I can have fellowship, a friendly association and feeling of goodwill, with any drunk (maybe even normal folks!) just by walking and talking out there in the wider world.

But being a member of this fellowship means bringing my recovery A-game inside our rooms, because that’s where we gather... and that’s where newcomers are directed to. I’ve got to pull my weight; do my bit for the team; share my experience, strength, and hope, so that there’s a place and at least one person to carry the message to the still sick and suffering alcoholic (no matter what their sobriety date is).

AA was here for me, it saved my life and sanity, and I want it to be here for the next guy. So today, I’m a ~~proud humble whatever~~ member of AA.

## Opportunities for Service

Right here, right now, there are service needs that are going unfulfilled. All AAs are more than welcome to bring their experience, strength, and hope (and their honesty, open-mindedness, and willingness!) to be of maximum service to all in Western PA. Talk an Area Officer or Coordinator for more details!

**COOPERATION WITH THE PROFESSIONAL COMMUNITY/PUBLIC INFORMATION (CPC/PI):** The CPC/PI Coordinator assists in informing the professional community (such as clergy, Employee Assistance Programs, educators, and legal and medical societies) about AA, and what it does and does not do. He/She assists AA district committees, groups, intergroups, and GSO; and also staffs AA exhibits at professional conferences, when asked.

**GRAPEVINE:** The Grapevine Coordinator is responsible for maintaining communications with the AA Grapevine office in New York. In addition, he/she displays and makes available the various Grapevine-related items and literature, as well as keeps area members informed about new materials issued by GSO. The display is present at all area quarterly and assembly meetings, as well as other events requested by districts and groups.

**WEBSITE:** The Website Coordinator is responsible for communicating and working closely with the Website Host (Webmaster) to insure the Area 60 website is as up-to-date as possible. The coordinator is also responsible for insuring the site is published following the *Area 60 Guidelines* and the Traditions of AA, as well as implementing changes to content, policy, and procedures from the Area Committee Group Conscience.

## Fellowship vs. Membership

AA is a group of men and women who share a common bond with each other: we are alcoholics. We are a group of like-minded people who share a common goal to live alcohol-free, and we have a set of 12 Steps to help us live this spiritual program of recovery.

I personally see it as a sort of fraternal organization. We are equals who come together to share our experience, strength, and hope with each other. I may not always have the same issues, but most of the time I can see myself in someone sharing. I drank for 30+ years, so I can always relate to the experiences part. But I always like when people share their hope – because without hope, I'm a lost cause. Without hope, I struggle, so that's why recovery is my main focus: clear-headed living without booze.

We come together, talk, and share about our alcoholism, and we live for our recovery. We may not always agree with others or enjoy their company, but in the 12<sup>th</sup> Tradition, it says we place principles before personalities. We help other alcoholics because we received help: we freely give away what was given to us. People who have time help the newcomer understand what goes on. Today, I see myself as a member of this group.

## Registrar's Duties

The **Area Registrar** is responsible for keeping all group records (meeting name; place and time; GSR, Alt GSR, and contacts) up-to-date in Area 60 by adding that information to the GSO database system, as well as recording addresses, phone numbers, and email addresses for all Area 60 service positions at the area and district level. There are about 858 active groups in Area 60 (but only 509 GSRs), and about 2,175 people total working in service to support the groups at the district and area levels. Working along with the Area Secretary and the Recording Secretary, the Registrar creates and updates a mailing address list for the area.

At the beginning of each year, the Registrar has to produce **Group Information Pages (GIPs)** for every active group to update all group information. The information is used to create the year's *Northeast Directory* at GSO; it comes out around September. The hope is that the *Directory* will help anyone searching for an AA meeting find one.

For Area 60, using email address reduces the cost of mailing out minutes, agendas, fliers, and just about any other correspondence with Area 60 groups. Mail can cost about \$0.75 per envelope, not to mention the time it takes to address, stuff, and bring them to the post office. Without an updated mailing list, many dollars are wasted on returned mail or sent out to people that no longer are in service (or, in some cases, no longer in AA).

There are about seven times a year that the Area Secretary does a mass mailing. Cost-savings on these mailings means that money can be used in other areas to better to help the still sick and suffering alcoholic. We now use email for about 80% of all groups with GSRs (or Primary Contacts), which at one time was all mailed by the U.S. Postal system. That's a significant expense that's been greatly reduced!

The Registrar also attends all quarterly meetings and assemblies in Area 60, as well as service events (like **Days of Sharing** and the **Get Away Weekend**).

I can go a long time without using my **AAA membership**; that means things are going good!

If I go very long as an **AA member** (and don't avail myself of the fellowship it offers), things will go badly!

## What's Good for the Group

### ***Through lots of trial and error, a member learns the importance of AA unity***

At first glance, unity seemed pretty simple. But after many years and much observation, for me it's not so simple. Almost all of my actions can reflect on that. If I'm not open-minded enough to investigate the things I propose to my AA group and examine all the pros and cons, but instead just try to push an idea through—without regard for the outcome—then I'm not interested in unity. I'm only trying to get my way. This happens far too often in the business meetings I've seen.

A prime example of lack of unity is the old fable that all it takes is a coffeepot and a resentment to start a new meeting. All we wind up with is two groups with resentments. And resentments are a dubious luxury that alcoholics can't afford. Often what happens is one or both groups eventually fade away.

Part of the education I've received in AA has shown me how to work out my problems by means of reasonable discussion. If I have a disagreement with my home group, there should be a calm discussion and an atmosphere of give-and-take, instead of belligerent disagreement and discord. This has also helped me learn to deal with things outside of AA.

Here are other ways that a group can help with unity: If we're planning an event, we could check and make sure we're not interfering with another group's activity. We try not to pick a date for an event without investigating first. Consideration is a key to unity. Also, if we see a need to start a new meeting, we look at the time and locations near someone else's meeting and try not to interfere with that.

In early sobriety, I had a lot of really good ideas that would have made AA work better. Thank God for strong sponsorship: My ideas got shot down and AA survived. With a wounded ego, I would go off and lick my wounds. What I learned from these experiences is that most of my great ideas came from the same brain that got me into AA, and that I was often only interested in being the most brilliant shining star in the room.

If we as sponsors try to teach that unity is the key to the survival of AA, not only will the program survive and flourish, but so will we alcoholics. In AA we learn the pitfalls of contempt prior to investigation, as well as the benefits of investigation prior to contempt.

I found that when I started studying the Traditions and began to use them in my daily life, just as I worked the Steps, it made living with others simpler. When I'm willing to look at the results of compromise, it brings about a degree of humility and open-mindedness that teaches me to play well with others, in and out of AA.

The biggest reward I will ever have in AA is to work with another human being, and this can only be achieved by an exchange of ideas, not by pushing my ideas on someone else. In other words, for the common good it might be time to give up on those old ideas I would fight and die for, and instead examine the ideas of others. No one person has the intelligence of "an informed group" of people.

## Getaway Weekend

An annual service workshop held in the spring to discuss General Service Conference-related issues and concerns affecting AA as a whole, as well as pertinent aspects of our **Three Legacies (Recovery, Unity, Service)**.



- ### Two Types of Area Meetings
1. **Quarterly Meeting:** Decides area business. DCMs, Area Officers & Coordinators, past Delegates vote.
  2. **Area Assembly:** Elects officers, provides pre-Conference group conscience, hears the Delegate's post-Conference report. GSRs, DCMs, Area Officers & Coordinators, past Delegates vote.

## Rules of Order at Area 60 Meetings

- Items for consideration are put on the agenda.
- Items are posed to the meeting in the form of a motion.
- All motions require a second.
- Motions can be amended, tabled, or moved to a vote.
- A vote is taken and the results are announced. The minority vote is allowed to voice its opinion.
- If a member of the majority (those who "won") wishes to change his or her vote, a second vote is held on the motion.
- The result of the second vote stands and the meeting moves to the next item for consideration.

### What's the Point of Order?

- ◆ To ensure that all voices that wish to be heard are heard.
- ◆ To ensure that no one voice dominates all others.
- ◆ To ensure that everyone gets to speak once before another speaks twice.
- ◆ To ensure that everyone understands the content of the vote.
- ◆ To ensure that it is clear what actions were taken.
- ◆ To ensure a thorough record of the actions taken.

Motions requiring substantial unanimity of the meeting require a two-third majority for approval. In some cases, the minority opinion (the people who "lost" the vote) may be larger than 50% of the vote.
